Tenders/RFP's and Quotes:

Recreation Master Plan

Yoho Park:

Part of the property has been cleared for the playground and parking lot. The playground equipment and pavilion have been approved by council, these can be purchased using the Canada Community Building Funds (formerly known as Gas Tax Funds). An RFP is required for the leveling of the property for a parking lot, the pavilion area and the necessary ground requirements for the playground equipment.

Storage & Office Building in Island View:

Departments of Justice & Public Safety are no longer using our storage facility, and our staff and summer students are moving to the location.

Merge Program- Land Identification:

Our first meeting was held with Maps Maps Maps Geospatial Solutions Inc. (formerly known as NB Mapping), and they will be working on multiple levels of mapping for Hanwell. This program will allow us to have everything in one program so that we don't have to search various government programs such as SNB, PLANET, GeoNB, our zoning maps, government wetlands, etc.

Merge Program- Identifying Water Sources:

Ecologia.AI has been awarded the contract to work with Hanwell and Arcadia on this project. They will also be working on tool that will allow us to identify water resources that they have obtained from available data through UNB, Google, GIS, GeoNB, and watershed data. There tool will allow us to ask questions and it will research our application to find the answers. We look forward to learning more about this project and working with Ecologia.AI's team.
